In future years, older people will form a greater proportion of Scotland's population than ever before, presenting new challenges for housing and support services in a time of increasing financial pressure.

How do we make better use of our existing housing stock to ensure that older people have homes that are safe and secure? How do we ensure that new housing meets the needs of older people? And that low level support services realise their potential, in enabling older people to remain in their own homes?

The Wider Planning for an Ageing Population report considers how we can meet these challenges in ways that are sustainable in the longer term.
